	<b>Personal Letter.</b> A personal letter from the applicant addressed to the Embassy of Sri Lanka, explaining the purpose of the trip, of travel, cities to be visited, and place of accommodation. The letter must be written and signed personally by the visa applicant or legal guardian.
teste	<b>Negative COVID-19 test result.</b> An applicant must provide a negative PCR Covid 19 test 72 hours before arrival. You also will be d again upon arrival. A third test will be given on day 7.

Travelers must stay within one of 52 properties

No preferential treatment will be given to travelers who have been vaccinated. All travelers including those who have been vaccinated must follow the Covid testing rules and stay at designated hotels for the first 14 days. All travelers will be required to complete a **health declaration form** upon arrival that states they are not suffering from symptoms of Covid-19. Temperature upon arrival will also be recorded. All travelers must be able to provide **proof of a round trip plane ticket and sufficient funds** to cover expenses while in Sri Lanka. Any nationals, who have been in UK during last 14 days **are not allowed to enter Sri Lanka**.
